1. Cataloging best practices - final review. Document reviewed and approved.
2. GPO Request for Information on Implementation Plan (response/routing of information)
Copies of the letter from Robin Haun-Mohamed, GPO and the response from the Dean's FDLP Steering Committee have been routed to the committee. There had been previous discussion about the steering committee sending a response and the question was raised about how public the response should be. It was decided to wait until Judy reports back on her up-coming meeting with Robin. If that meeting adequately addresses the open issues, then this group need not respond. If not, a letter of support for the Dean's response was suggested.
3. Deans FDLP Steering Committee, Florida Disposition Database Phase II
The Deans committee recommended an October 1 timeframe for Regionals/Selectives from the ASERL region to be registered and using the Disposition Database. Committee members felt that with the start of school and new staff members, the October 1 date may be a little optimistic for everybody to get set up. Two demonstration sessions on the Database have been scheduled for Depository Coordinators. The August 11 session had a fairly low attendance due to short notice of the event. Currently 79 people are registered for the September 1 session.
4. Training Committee - request for volunteer
The recommendation was made to review the grant documentation and determine if our current training/promotional activities are meeting grant requirements without forcing the need for an additional committee and that perhaps it is time to retire the training committee? Cheryle will review the documentation and provide an update.
